- ✓ Free of external parasites of any kind!(including fleas, ticks, mites, etc.)
- ✓ Friendly with other dogs and people.

1. I agree that in admitting my dog(s) to Country Pet Resort & Spaw, my representations are true and have not been falsified to gain admittance to Country Pet Resort & Spaw. My dog(s) meet the above requirements and I authorize my veterinarian to release all information regarding the status of vaccinations, spay/neuter, age, medications and health condition(s) of my dog(s).

2. I agree that my dog(s) has/have not harmed, shown aggression, injured or exhibited any threatening behavior towards any other person or dog.

3. I understand that Country Pet Resort & Spaw provides a group play environment and that during normal dog play my dog(s) may sustain injuries, scratches, bites, punctures, gastric torsion(bloat), torn/strained ligament, etc. arising from such play. Although Country Pet Resort & Spaw carefully monitors to avoid such injuries, they could occur despite the best supervision.

4. I understand and agree that if my dog (s) is/are the cause of injury or death to another animal or person, I shall be legally and financially responsible for the cost of injury, death or damage. This includes, but is not limited to, same family pets staying in any together such as suites, play areas or kennels. I agree to fully indemnify Country Pet Resort & Spaw and its principles, employees,

agents, volunteers and representatives for any costs, losses or legal expenses incurred in their defense or any other claims, including negligence, brought by myself or a third party arising from or related to my actions or the actions of my dog(s) while on the premises or in the custody of Country Pet Resort & Spaw.

5. I understand that Country Pet Resort & Spaw requires all dogs, playing in group play, to be spayed/neutered (if 6months or older).

I understand that even though my dog is current with the required vaccination, there is a possibility that my dog(s) could still contract Kennel Cough, Canine Influenza, Upper Respiratory Infection, Giardia or any other such illness. Any pet deemed sick or unhealthy during his/her stay will be isolated from the group and Country Pet Resort & Spaw has the right to seek veterinary treatment on my behalf if I or my emergency contact cannot be reached. If this occurs, I am financially responsible to pay any and all expenses incurred for veterinary treatment during or after my dog(s) stay at Country Pet Resort & Spaw.

7. I authorize Country Pet Resort & Spaw to arrange emergency care should need arise and thereby release Country Pet Resort & Spaw from all liabilities relating to the transportation, treatment and expenses of such care. Should my specified veterinarian be unavailable, I authorize Country Pet Resort & Spaw to engage the veterinary services of choice. If I or my emergency contacts cannot be reached in a timely manner, I authorize Country Pet Resort & Spaw to approve medical and/or emergency treatment as recommended by a veterinarian. I will reimburse Country Pet Resort & Spaw for all veterinary expenses incurred.

8. I understand and agree that if my dog is taking medication it is my responsibility to leave an adequate supply during the time that my dog(s) is/are cared for by Country Pet Resort & Spaw. Should the supply need replacement, I authorize Country Pet Resort & Spaw to purchase the replacement and I will reimburse Country Pet Resort & Spaw for the cost.

9. I understand that Country Pet Resort & Spaw reserves the right to remove any dog(s) that become(s) a nuisance, creates a disturbance on premises, or is uncontrollable at any time while under the supervision of Country Pet Resort & Spaw. This may include, but is not limited to: barking, howling, fence jumping, rough play, biting, or destructive behavior to property.

10. I agree, upon check-out, to provide full payment for all services rendered by Country Pet Resort & Spaw. If payment is not made in full then Country Pet Resort & Spaw reserves the right to hold my pet until such payment is made. I understand that Country Pet Resort & Spaw has a strict no refund policy and will not refund any payment of any kind for any reason.

11. I understand that if my dog(s) is/are not picked up by the designated/scheduled pick up time, then I hereby expressly authorize Country Pet Resort & Spaw to take whatever action is deemed necessary for the continuing care of my dog(s) and I agree to pay Country Pet Resort & Spaw all costs of continuing such care upon demand by Country Pet Resort & Spaw. Further, I understand that if I do not pick up my dog(s) as designated/scheduled, Country Pet Resort & Spaw shall be authorized to proceed according to California Civil Code section 1834.5.

“(a) Notwithstanding any other provision of law, whenever an animal is delivered to a veterinarian, dog kennel, cat kennel, pet-grooming parlor, animal hospital, or any other animal care facility pursuant to a written or oral agreement entered into after the effective date of this section, and the owner of the animal does not pick up the animal within 14 calendar days after the day the animal was initially due to be picked up, the animal shall be deemed to be abandoned. The person into whose custody the animal was placed for care shall first try for a period of not less than 10 days to find a new owner for the animal or turn the animal over to a public animal control agency or shelter, society for the prevention of cruelty to animals shelter, humane society shelter, or nonprofit animal rescue group, provided that the shelter or rescue group has been contacted and has agreed to take the animal. If unable to place the animal with a new owner, shelter, or rescue group, the animal care facility may have the abandoned animal euthanized.

(b) If an animal so abandoned was left with a veterinarian or with a facility that has a veterinarian, and a new owner cannot be found pursuant to this section, the veterinarian may euthanize the animal.

(c) Nothing in this section shall be construed to require an animal care facility or a veterinarian to euthanize an abandoned animal upon the expiration of the 10-day period described in subdivision (a).

(d) There shall be a notice posted in a conspicuous place, or in conspicuous type in a written receipt given, to warn a person depositing an animal at an animal care facility of the provisions of this section.

(e) An abandoned animal shall not be used for scientific or any other type of experimentation.”
